Provides clients of the Bureau of Vocational Rehabilitation (BVR) with information on rights and responsibilities according to the Rehabilitation Act of 1973. Offers consultation on securing needed services, negotiation when services are denied or delayed, and assistance or representation in appealing a decision regarding a vocational rehabilitation program.

Protects and advocates, through legal advice and legal counsel, the rights of people who have, or are alleged to have, mental illness. Represents the views of the individuals with disabilities themselves.

A place to turn if you have a Fair Housing legal issue. The Fair Housing Act, originally passed in 1968, prohibits discrimination in housing and related transactions on the basis of race, color, national origin, sex, religion, disability and familial status.
